The trust seeks to provide a percentage return per unit on the Maturity Date equal to 150% of any percentage increase in the SPDR[®] S&P 500[®] ETF (SPY) relative to the Initial Reference Value, up to a maximum return of 34.88%. If the value of SPY decreases from the Initial Reference Value, the return on the units will be negative and will equal the percentage decrease of SPY.

How it works

In pursuing its investment objective, the trust intends to hold a fixed portfolio of exchange listed options on SPY and cash.No assets in the portfolio will contain any corporate or bank credit risk (please refer to the following page for selected risk factors).All portfolio components will be disclosed in the final prospectus. Once issued, units will be redeemable on a daily basis at their net asset value (NAV).Redemptions prior to maturity may result in not meeting the trust's investment objectives. 
