#### Investment objective

The trust will seek a percentage return per unit on the maturity date equal to any percentage increase in the value of the Invesco QQQ Trust, Series 1 (QQQ, the Reference Asset) relative to the initial reference value, up to a maximum return of 31.00% while also providing protection against the first 20% decrease (the Buffer) in the value of the reference asset.

#### How it works

In pursuing its investment objective, the trust intends to hold a fixed portfolio of exchange listed options on QQQ and cash. The portfolio will not contain corporate or bank credit issues (please refer to the following page for selected risk factors). All portfolio components will be disclosed in the final prospectus. Once issued, units will be redeemable on a daily basis at their net asset value (NAV). Redemptions prior to maturity may result in not meeting the trust's investment objectives. All returns will be subject to reductions due to ongoing trust fees and expenses.


